Instructions on delivery/despatch and processing



You must complete a "Request For Irradiation of Bee Equipment" form

Contact Steritech's Operations Manager for information on processing dates/times

Deliveries are accepted Mon - Fri, 8am - 3.30pm

The equipment must be:

- Free of Honey
- Double Metal Emlocked (each unit)
- Under 25kg (each unit)
- Bee, insect and spider free
- Double bagged or shrink wrapped
- Labelled with the name of the Beekeeper (each unit)



Once completed, Steritech will contact you

You can then pick up the equipment Mon - Fri, 8am - 3.30pm

Payment can be made when you pick up the equipment

A Certificate of Irradiation and the treated equipment is then given back to you
